Minimum services of the funeral director and staff:

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee includes the following: Personnel available 24 hours a day, 365 days a year to respond to initial call, arrangement conference, coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased, clerical assistance in the completion of various forms associated with a funeral. It also covers overhead, including facility maintenance, insurance and governmental compliance.

Transfer of remains to funeral home

Transfer to funeral home within our covered area (for cities within the San Fernando Valley and Santa Clarita Valley) \$195.00
 Transfer to funeral home outside our covered area (for all other areas of Los Angeles County) \$275.00
 Transfer to funeral home outside our covered area (for Ventura County) \$355.00
 Second person removal (required at homes and certain cases where two people are needed)..... \$75.00
 Transfer to funeral home for outside funeral home includes holding for pick up..... \$495.00
 Transfer to/from Coroner's Office \$200.00
 Additional mileage outside normal service area is \$ 3.00 per mile

Refrigeration

Use of refrigerated holding room (additional charge may apply if we hold past seven days per your request)..... \$95.00

Other care of remains

Dressing & personal care.....\$250.00
 Sanitary care of unembalmed remains (shrouding un-embalmed remains for I.D. purposes) \$95.00
 Use of refrigerated holding room (additional charge may apply if we hold past seven days per your request).....\$250.00
 Use of preparation room for religious washing and dressing.....\$450.00

Direct Cremation (Usually complete within 7 working days, depending on Dr's availability to sign D.C.)

Basic professional services and use of facilities, local transfer of remains to funeral home, sanitary care, use of refrigerated holding facility, and transportation to crematory. (This fee does not include crematory fee, cemetery and funeral bureau fee, permit or urn.)

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or comparison materials (with or without an outside covering).
